

## New Russian Cosmism

## Conception of the Living Universe

1.

For more than 40 years of a comprehensive study of the UFO phenomenon and other so-called "anomalous" phenomena, during which a huge amount of data was obtained, including through direct communication of specially trained people with representatives of extraterrestrial (ET) civilizations and subsequent analysis of the information obtained in the light of modern scientific knowledge, existing religious concepts and views of Russian space scientists (Russian cosmists<sup>1</sup>) of the XIX-XX centuries, we became firmly convinced that:

1) *The whole Universe is alive*. And we, as a part of Its large living organism, are supposed to and must live in harmony with the Laws established by the Universe for all its inhabitants and Itself.

We have discovered and deduced these Laws ourselves, and the information received by our specialists directly from the Supreme Intelligent Powers of the Cosmos<sup>2</sup>, confirms the absolute correctness and reliability of this discovery.

We have called these Laws the Fundamental Laws of the Universe. They are mandatory and unchangeable for everyone.

Ignorance of the Fundamental Laws of the Universe does not exempt you from responsibility for the non-compliance with them.

The Fundamental Laws of the Universe determine and direct the evolution of both the Universe itself and everything that lives and exists in it. In total, there are 5 Fundamental Laws of the Universe:

- The Law of Development and Perfection. The Law of Development and Perfection states that *humanity is obliged to fulfill its Cosmic Purpose*<sup>3</sup>, for which it was born. The Cosmic Purpose of humanity is to ensure and maintain a continuous process of development and perfection of itself, its world (planet Earth) and its star system (the Solar System).
- The Law of Harmony and Beauty. The Law of Harmony and Beauty requires that the process of development and perfection, guided by humanity in its world, must be harmonious, that is, that in the human world there must be harmony between Masculine and Feminine<sup>4</sup>. In humanity, it is the *harmony between a Man and a Woman*, based on Love, which will allow people all over the world to achieve full coherence, mutual understanding and unified aspiration to advance to a *creative* level of being.
- The Law of Change. The Law of Change establishes that for humanity only its Cosmic Purpose is *permanent*, and humanity is obliged to fulfill it under any circumstances; everything else the external and internal conditions of humanity's existence, the level of consciousness at which a human being is, the state of human society, etc. is in a constant process of change.
- <u>The Law of Justice (Retribution).</u> The essence of the Law of Justice (Retribution) is that anyone who, acting consciously or unconsciously, tries to harm the

surrounding world (people, animals, nature, etc.), instantly receives such a degree of force of the reverse action, which is directly proportional to his desire to destroy the surrounding world. People use to call it *Karma*.

At the same time, the Law of Justice is manifested in the fact that by *constructively* investing in the overall process of development and perfection of his world, taking care of others, caring about nature, setting a good example to his children and people in general, man actually enhances his own well-being, improves his health, makes his future brighter, creates for himself a transition to a new level of consciousness and a new level of mastering the potential of his physical body. Thus, man prolongs his life and gains the *ability to evolve*.

• The Law of Order. The Law of Order establishes the Hierarchy of Powers in the Universe<sup>5</sup> and ensures the existence of the human world in accordance with the Fundamental Laws of the Universe in all their multidimensional manifestations.

This means that humanity, being not the only conscious manifestation of life in the Universe, must take into account the possible consequences of its activities, and what impact the results of this activity may have on other inhabitants of the Universe. That is, *humanity*, as well as all other inhabitants of the Universe, must follow the Ethics of the Cosmos<sup>6</sup>.

2) Each star system has its own *main acting force*, which is responsible for both its own evolution and the evolution of the star system.

Entities of a higher level of development, that is, those at a higher stage of evolution, in the role of which, for example, are extraterrestrials for us, for ethical reasons *can not* invade, as it is often depicted in Hollywood movies about "evil alien invaders", in other worlds. Nor can they, at will alone, interfere directly with the course of events and adjust the direction of the evolution of any star system that is in the sphere of responsibility of another race, even if it is at a lower level of development. However, the Supreme Intelligent Powers of the Cosmos can give hints to their younger brothers

in consciousness: to point out the existing shortcomings in activity, errors in behavior, incompleteness of perception of events, that is, everything that can lead to irreparable consequences.

In addition, the Supreme Intelligent Powers of the Cosmos have the opportunity to observe us. And those UFOs that we see in the Earth's atmosphere and near-Earth space are mostly not ET manned ships, but *drones* from other worlds designed to monitor the situation on our planet and in our Solar System. After all, there are Forces<sup>7</sup> that are responsible not only for their own star system, but also for the entire Galaxy.

3) The Hierarchy of Powers in the Universe is built depending on the *level of consciousness* of the beings inhabiting it. The higher the level of consciousness possessed by a particular race living in the Universe, the more evolutionarily developed it is, and, consequently, the higher the position of this race in the Hierarchy.

The level of consciousness of each race is expressed in the ethics and morality of the behavior of this race both in relation to itself and to the entire world around it. The higher the level of consciousness of a race, the more ethically and morally its representatives behave, striving not only to prevent the death of their population, their planet, their star system, but also to contribute in every possible way to the evolution, development and perfection of themselves and other beings of their world.

The level of consciousness that humanity currently possesses is insufficient not only for a sustainable evolutionary development of humanity itself, but also for its simple survival on the planet. For the present, humanity is internally divided and mostly morally degraded, therefore, can it not only destroy itself through wars and civil strife, but also its consumer and barbaric disregard for the nature and ecology of the planet threatens the survival of the Earth itself.

In addition, people do not yet understand that humanity is a single organism. That is, in fact, humanity exists like a swarm of bees, or like an anthill. By the way, neither inside a swarm of bees, nor in an anthill between ants there are no wars and enmitties.

These creatures never destroy their fellow specimens or themselves, as humans do today.

Therefore, the Supreme Powers of the Cosmos will not allow human hostility to be transferred to other levels of the Universe, including near-Earth space and deep space.

In order to advance to a constructive, safe for ourselves and the world around us, way of existence, *humanity needs to raise its level of consciousness*.

2.

We have developed special methods and techniques for raising the level of consciousness of the human through the restoration and strengthening of morality. These methods and techniques have been tested through the decades on tens of thousands people.

In the course of our research and work on the problem, we encountered one important issue to be resolved, which resides in the following.

Figuratively speaking, the human has two sides: "light" and "dark".

The "dark" side is the *ego* (egoism) of the human, which carries destructive energies. That is why everything that the ego "touches" gets destroyed and degraded.

The "light" side can be called the *Essence* of the human, that is, the projection of his Soul<sup>8</sup> into his physical body. The "light" side of the human brings creation, development, peace and all the best that is natural for any *human being*.

Since the Middle Ages, *two misconceptions* have taken root in humanity that:

- 1) The human physical body is just a *biological machine*. This belief was imposed by Descartes.
- 2) All the *egoistic qualities*, that is, the qualities that the ego possesses, are inherent in the physical body of man. If so, it follows that these qualities are innate and unchangeable attributes of the physical body, so it is impossible to get rid of them.

However, we found out that this is not the case at all.

The ego, with its egoistic qualities – is a kind of virus that is now infecting humanity. And therefore, all diseases in people, including mental ones, occur precisely because of the ego. At the same time, being a parasite, the ego "eats" the life force of the physical body of the human.

We managed to develop ways to *transform* the negative, destructive psychoemotional energetics of egoism into a positive, creative energy. Thanks to the transformation of egoism, people's illnesses disappear, depression goes away, and a state of *joy* appears. Joy inspires human, motivates him to continue perfecting himself and becomes a criterion for the correctness of the methods and techniques used by him to strengthen morality and increase the level of his consciousness.

The ego keeps people at a very low *consumer* energy level. Because of this, people are mostly unable to create. And this is reflected in all spheres of human's existence: in the family, in society, in the attitude of the human to his physical body, to nature, etc. Transforming the ego, we consciously change the general attitude of the human to everything in his being from consumer to creative.

The solution of this task of the transformation of the ego will allow humanity to get out of the clutter of egoistic existence and *regain the status* of moral, creative and harmoniously developing beings – the status inherent in every *humanoid civilization*.

Man and all aspects of his existence are closely interrelated with the ecology, with the nature of the planet Earth. The facts that the human body is 80% water, and that life on our planet originated in water, already say a lot. The waters of the World's Oceans, together with the radiation that the Sun gives, make our life possible and constantly fuel it.

Experiments conducted in the Soviet Union and then repeated in Japan showed that water is a "liquid crystal" with the properties of a hologram. This means that any arbitrarily small part (portion) of this liquid crystal – water – has the same properties and carries the same information as the entire mass, the entire volume of this crystal (the World Ocean), represented in a given space (on the planet Earth).

For humanity, this means that by polluting the oceans, draining the waste products of our activities there, and thus poisoning the water bodies everywhere, we are actually poisoning

ourselves. After all, our body, consisting of more than 80% of water, being a small part of the World Ocean, instantly acquires both all its positive and all its negative properties. We are like a small holographic projection of all the processes taking place in the World Ocean. And it has already been established that water transmits and receives information very well, regardless of how physically far or close its different parts are.

As the physical and chemical poisoning of the water in the oceans increases, people feel increasingly depressed, downtrodden, and experience a moral decline. There are headaches, emotional deafness, apathy and other psychophysical disorders. This is how, at the initial stage, the negative processes that are currently taking place in the World's Oceans as it is polluted by people are manifested in the human body.

Our experiments have shown that in order to facilitate the psychophysical state of a person and get rid of the "permanent depression", sometimes it is simply enough to visualize at the level of your imagination how you would clean a nearby reservoir or river bank from garbage. Especially surprising positive changes in their states were noted by the participants of the experiment when they performed the above actions, engaging their ideomotor reactions.

This happens because our body and psyche instantly and with a fine accuracy react not only to external physical influences, but also to our thoughts, emotions, intentions, desires and everything that happens in the sphere of our imagination and at the level of our perception.

This is how our body, psyche and psychoenergetics<sup>9</sup> work in such an indissoluble connection with the whole world around us.
