Fruits of humanity's "progress"

I will start talking about the cosmos with earthly affairs, with the question: is the path of development, chosen by the humankind, right? All the more so, that virtually all nations and civilizations associate their emergence on planet Earth, existence and further development with the divine origin, while all world religions positively associate this very origin, as well as the actions of the nursed by them masses and governments, with God. And when it comes to the Almighty, people raise their eyes to the sky, peer into space, offer their prayers to it.

Let's now talk about the path chosen by man as a direction for his development. Let's look back in history: for the last five and a half thousand years of humanity's "progress", there were only 300 years without wars, the rest of the more than five millennia in the most different corners of the planet there were wars and armed conflicts in full swing. And probably all the conflicting parties involved in the battles fought in the name of God, under his banner or for his sake. Every nation, its leaders, if they have something outstanding in their history, it is, first of all, the battles won. And the essence of victories in battles — is a greater number of killed and defeated enemies, more extensive destruction, obliterated cities, destroyed forests and crops, devastated population. Is this progress in development?

At the same time, the more superior knowledge the humankind receives (from outer space), the more effective weapons people produce. Effective means: more destructive and murderous. For more than half a century, nuclear weapons were considered the most "effective", but today even more terrible types of weapons are being rapidly developed and ramped up: climatic, genetic, cybernetic, capable of not just killing in greater numbers, but destroying certain races and nationalities, huge regions of the planet with one (subtle) strike, provoking climatic and other "natural" disasters, disabling the life support systems of not only countries but also continents. And, of course, in the most hidden institutions and laboratories of the "most developed countries of the modern world" they search for and lay foundations for such weapons, with which it would be possible to destroy all of humanity or most of it, saving only a few tens of millions of the chosen ones, or to be more precise – the "God-chosen". Or to destroy the consciousness of humanity, turning it into obedient and weak-willed slaves. That is, to complete what Hitler had not accomplished. The implementation of this dream is viewed by the so-called world elite as the highest achievement of the "progressive" humanity. Yes, for a regular (not elite) person, this seems to be the height of insanity, but, alas, the world is ruled by the "elites", albeit insane.

Let us turn once again to the history of how the "progress" of a creature named Homo sapiens evolved. Man has successively mastered the three spheres of his environment – land, water, and air. What are the results of this mastery? What has he, the intelligent, turned these three spheres of environment, in which he lives and "progresses", in? The scientific community and especially the environmentalists holler that the oceans are dying, being killed by man. It is already stated that a third of the world's oceans is not suitable for living organisms, areas of islands made of plastic and other products of human activity grow, flocks of marine animals (whales, dolphins) throw themselves out on land, species of marine animals and fish disappear, whole seas (Aral, Black, Baltic) have died or are dying. Land, mastered by man, becomes a concentration camp and a cemetery for thousands of species of animals, insects and birds, while megacities – those for its residents. Moscow, for example, has long been recognized as one of the most unfavorable areas for living, almost never healthy children are born here. We can see from the Russian reality that the problem of littering the country's territory is becoming almost the main concern of the President and the government. I propose you a generalized assessment of the aftereffects of the "intelligent" creature's activity in the air environment, coming from an academician.

"I don't know if people are aware that the volume of industrial production, the volume of construction, the volume of energetics, transport, doubles every 8-10 years... What is the result of such growth? *The exponential growth of industrial production is leading us to our demise.* The fact is that since the beginning of the century, the pollution of the air basin of our planet has increased more than in 1000 times... Still, we are alive. But when 10 more cycles of the industrial production doubling happens and the overall air pollution increases in one million times, it will be impossible to live on the Earth. Simply because there will be no air to breathe... The extraction of raw materials from the bowels of the Earth is estimated by many and many billions of tons, exceeding the capacity of global natural geological processes. From this huge monstrous amount of raw materials extracted from the bowels of nature, human society uses one or two percent for its needs, and the rest in an ecologically distorted form is thrown back into the natural environment in the form of a waste, poisoning all the living." This is stated by a Soviet academician, a profound, true scientist. Let man enter an environment, that environment will soon be dead.

So outer space will be no exception, as long as humanity has a destructive type of consciousness, as long as the priority of its development are getting benefits and supersatisfaction, and environment serves human as a commodity and a means of enriching the so-called elites ("chosen by God"), and as long as these, the most incompetent, standing on a much lower level of evolution than any reptile, "elites" determine the advancement of our country and the whole humankind.

Let me put here another quote from my Russian colleagues, true researchers, and with whom I do not quite agree.

"At the beginning of the third millennium, civilization advances, obeying the programs laid down as the basis for most biological systems. These are, in the first place, programs of survival and reproduction – that is, programs of the animal world, the zoosphere, ...the program of an unrestrained enjoyment, factors of individual and group dominance leading to an expansion." I will not agree in the part where the programs of the animal world are exposed by a negative factor. Because all species of the living in accordance with the bio-programs inherent in them perform functions generally beneficial for all the living, and thanks to it harmony is maintained in nature. In particular, our tiniest brothers-creatures guard the nature, cleaning up garbage and other results of our "intelligent" activities for us. As for Homo sapiens, he is, basically, a destroyer and lives outside any programs; moreover, Western Nations and many Russians have even lost the function of reproduction.

What awaits us and the cosmos?

Predicting the global situation even for the period of the coming years is becoming increasingly difficult. Firstly, because there are too many unknowns (unpredictability) in the formula of the future. Secondly, there is a scrapping of ideas about the fundamental foundations of the universe, formed during the previous millennia. And thirdly, there happened a synthesis of global man-made threats with cosmo-natural threats to the existence of the "homo-sapiens". It turned out that man, endowed with a mind not limited in development, created a system on the planet leading to the demolition of life on Earth, because he directed the mind not to create, but to destroy and challenged the environment in which he lives, and on which he is completely dependent.

The natural environment has been evolving on the planet for billions of years, passing the most complex evolutionary stages by trial and error, disasters and cataclysms, until it built a harmonious system of interdependence and interaction of the plant, animal and intelligent worlds. In addition, this system is most directly related to the cosmos, the higher mind, the processes in the Universe. It is the system of the planet Earth, which is inscribed as a minute particle in the universal system. And on the planet Earth, there were surprisingly created conditions for the "preferential" survival and development of man, endowed with the property of reason, which no other living creature possesses.

Let us turn to the words of a remarkable researcher, Vice—President of the Academy of geopolitical problems T. R. Timerbulatov (Mon Tirai): "...the world is arranged very reasonably, logically and rationally. The world, as if on purpose, was created for man. The sun gives people heat and light, but they do not pay a penny for it; the Earth's magnetosphere protects them from cosmic rays, although people did not ask for that; completely without people's participation, night follows day, creating conditions for every living thing; leaves appear on trees in the spring to provide oxygen to living organisms; the deficiency of oxygen with the onset of winter in the Northern hemisphere, is countervailed with the trees in the southern hemisphere: ...the water in rivers, lakes, seas and oceans in the form of snow and rain flows equitably and rationally is distributed across the area of the planet where there is no pond, but there is life... the World lives by strict rules, and violating of these rules is impossible... Everything is strictly regulated. Everything is in its place. And every living creature on this planet knows exactly what it can and what it can not... Everyone knows the rules, knows and follows. Because there is no other way. Otherwise it would be chaos, destruction of the system, cessation of life."

We can complement the statement of the scientist with countless facts showing that thousands of species of animals, fish, birds, insects exist to "serve" the human, provide him conditions for a comfortable life, liquidate negative consequences of the anthropogenic activity. Whereas outer space for the human and all the living is certainly a cradle and a parental home. It is not something mechanical lifeless, but the very source of life and life itself. The cosmos, near, far and infinite is a diverse and multidimensional living space bestowing life upon planet Earth.

Now let's turn to the language of modern economics and speculate on the investment of space and planetary nature in man for the past many millions of years. For example, how much does it cost in dollars, rubles, euros or yuan, the creation of the atmosphere on the planet Earth, of a certain chemical composition, atmospheric pressure, global movement of air masses, with the maintenance of appropriate climatic conditions? What about cultivating huge forests, green fields,

regulating the process of their flowering, fruiting, conservation in a vital state until the next season? All this is not accidental, not chaotic, but thoughtful, well-designed. Each species of living organisms has a clear biological program to perform certain functions, maintaining balance and harmony, for the benefit of man, above all. Simple observations of nature show that: first of all, all living creatures without exception work furiously, performing their "social" duties, and secondly, any kind of life, except Homo sapiens, lives not for itself, but for the maintenance and development of life on the planet.

Well, since all the living feeds on from outer space through a living cell, we positively can talk about a cosmo-planetary essence of life on Earth, a project of the Universe, about the universal Law of life and development, life maintenance patterns on planet Earth. And all living entities on our planet must be subjects to these laws and patterns. In case a species has fulfilled its function, or has altered it without validation, it disappears, either by a slow extinction and replacement, or by a rapid extinction. There should not be anything superfluous, all the more harmful in nature. Only socially beneficial activities and existence. There are no investments for useless vegetating in the heavenly accounting office. This is the iron law of life and evolution. Furthermore, live nature has its hierarchy of power, management organization system, to be more precise. It comes from the cosmic heights, too. A lot of interesting things here as well.

Since childhood, I observe the ants and try to understand how this mass of thousands from early morning until late at night works without smoke breaks and lunch hours, even without salaries and bonuses. Moreover, works not chaotically, but organized, without shouting and cussing. Building something, harvesting, erecting infrastructure, eliminating the infection left by man (doing sanitary work). The orderliness and clarity of actions of each ant is regulated, in my opinion, by a strict biological program given to the ant community and a specific bio-plan – to each individual ant. As Suvorov said: everyone knows his maneuver. There are leaders, whose functions I still have no clue about. The only thing that is clear is that they issue energy impulses of control, and possibly engage other bio-programs in the event of an emergency situation. It's not easy to identify a leader (chieftain) in the ant community: he has no advantages over others and no distinctive signs. And the whole community is governed by a field of a peculiar bioenergy, whereas each individual is both the source of the energy and the receiver of cosmic energy (solar and other energy). I give this example to show that all living things act within certain energy-informational systems, acting as a whole in any manifestations from the cellular level to celestial bodies.

I think, what man does and what he will do to space, is rather understandable to any sane being, and to specialists all the more:

"With the beginning of the space exploration era, a fundamentally new and dramatic event occurred in the ecology of the Earth and near-earth space (NES): in this space of human activity, a population of man-made objects appeared and began to grow rapidly, among which the so-called space debris is an increasing share." Let me remind you that until 1957 (before the beginning of the space era), experts, science fiction writers, space theorists wrote and talked about threats to humanity from space, but those were asteroids, meteoroids and other space bodies (up to 40 thousand tons annually) considered as threats. Today this threat reversed – man is a threat to space, to the security of outer space, and not only. Space debris has become a threat to launched objects and to vital objects and people on Earth. On February 10, 2009 the non-functioning (litter) Russian "Cosmos-2251" and the American (working) "Iridium-33" collided in orbit, both orbiters dead, while several million pieces of different sizes came as the result of the collision. And some of the pieces can possibly reach the surface and pierce someone or something at a great speed. The intentions to commercialize outer space, that is, to make profits, can not but cause alarm. They develop extensive programs on launching of thousands of spacecraft for various purposes into

different orbits, new type (including ultra-light) boosters; the list of private corporations working in space is expanding, but there are no international programs to "clean up" outer space from human debris. Moreover, today they turned their "profit-seeking" eyes to the Moon.

In fact, they talk about the colonization of the lunar surface. "The Moon today is the most attractive object in the outer space for world powers, rich in territories and resources. Colonization will begin in the near future, and the race for a place under the sun on the Moon is already in full swing." However, the main threat from outer space is the military activity of man in space "to protect national and private interests." And we know that profits, especially private ones, are protected in the strongest possible way. Therefore, today, in parallel with the study of lunar resources and methods of how to deliver them to Earth, the issues of creating military bases on the Moon and ensuring the safety of the delivered goods are there being discussed. Projects of such bases are currently being developed, in Russia as well.

So today, outer space is becoming the scene of a tough military confrontation. Here is what the President of the Academy of military Sciences, an outstanding military expert, General of the army Gareyev M. A. says: "With the modern nature of armed struggle, its center of gravity and main efforts are transferred into the aerospace environment. The leading powers of the world make their main bet on the conquest of dominance in the air and outer space by conducting massive air and space operations at the very beginning of the war." Thus, the aerospace environment, being the source of life on planet Earth turns into the main battlefield of the XXI century. And this is also the result of implementation of the Western path of "development, prosperity and progress" of mankind. Yet, this will be a verdict not on space, but on humanity. In the first phase of such operations, outer space will be used for the mass destruction of people and objects on the planet, on Earth, in the air and in naval theaters. But the laws of war will require the transfer of military operations directly into outer space, because that is where not only the means of communications, navigation, guidance and intelligence will be concentrated, but also the strike means, including new types of weapons of mass destruction.

Consider some space innovations.

1. A new means of psychological influence, which can be widely used in practice, are generators of holographic images in the atmosphere, being produced by laser radiation. In a number of countries, they develop projects on installation in the existing spacecraft of laserlight complexes capable of projecting various images onto clouds. Clouds appear to be an outstanding natural screen located at an altitude of 60-80 km from the Earth's surface. The image projected on them will be clearly visible at a distance of 100-150 km. A case of this kind was reported on February 1, 1993 in Somalia, when a group of US marines operating near Mogadishu noticed in the clouds of dust and sand an image of the face of Jesus Christ measuring approximately 150×150 m. Describing their mental state, the marines told that they were crying on their knees, and for a long time were unable to continue the combat mission. Currently, in the United States, they plan to create holographic images of Islamic preachers in the sky, who "from heaven" would advise their co-religionists to stop resistance, surrender to the mercy of the enemy or return home. Thus, an unexpected contemplation of the images of saints, monsters (dragons, lizards, mutants, etc.) or other unfamiliar phenomena can have a strong psychological impact on people, both of a mobilizing and demoralizing nature.

- 2. Other the most common types of psychotronic weapons used from outer space are:
- * generators of electromagnetic radiation;
- * infrasound and ultrasound generators;
- * laser and light emitters;
- * generators of special radiations;
- * computer (cybernetic) technologies, etc.
- 3. Geophysical weapons are weapons which destructive action is based on the use for military purposes of natural phenomena and processes triggered by artificial means. Depending on the environment in which these processes occur, it is divided into atmospheric, lithospheric (tectonic), hydrospheric, biospheric and ozone. The means by which geophysical factors are stimulated may differ, but the energy expended by these means is always much less than the energy released by the forces of nature being the result of the geophysical process induced.

The intensification of research into the development of mass destruction weapons has led to a significant increase in the risk of war in space.

So, dear reader, the progress of mankind under the leadership of the West will accelerate the end of our tenure on planet Earth.

What about the UN Charter?

75 years ago in February 1945, two great men – the U.S. President Franklin D. Roosevelt and the Soviet leader, Chairman of the USSR government, I. V. Stalin at the Yalta conference of allied leaders "pushed through" the establishment of the UN and the acceptance of the principles of secure development of all nations of the world, have started the process of decolonization of humanity, acknowledged the equality of all nations and states.

"We, the peoples of the United Nations, are determined

to save succeeding generations from the scourge of war, which twice in our lifetime has brought untold sorrow to mankind...

...and for this ends

to unite our strength to maintain international peace and security, and

to ensure, by the acceptance of principles and the institution of methods, that armed force shall not be used, save in the common interest, and

to employ international machinery for the promotion of the economic and social advancement of all peoples.» 8

These are the remarkable provisions, by the enormous efforts of F. Roosevelt and I. Stalin laid down in the UN Charter. But it seems that these very provisions and the launch of the decolonization process cost the US President his life. So I was told by some respectable Americans. The large international capital has not forgiven the loss of huge profits from wars and colonies. With the passing of I. Stalin, the Yalta agreements blur and are not being implemented. The arms race covers land, sea, air. In the 60s of the twentieth century, the militarization of space begins. The USSR, with the support of socialist and neutral states, tries to create an international legal framework for peaceful space.

On January 27, 1967 upon the initiative of Moscow they signed the Treaty on space (full official name: the Treaty on the principles of the activities of states in the exploration and use of outer space, including the Moon and other celestial bodies) - an intergovernmental document. The Treaty was signed by the United States, Great Britain and the Soviet Union. Today, more than 120 countries are states-parties to the Treaty.

The **Treaty on space** defines the basic legal framework of international space law. Among the principles there are the prohibition for states-parties to place nuclear weapons or any other weapons of mass destruction in the orbit of the Earth, to place them on the Moon or any other celestial body, or on a station in outer space. This Treaty limits the use of the Moon and other celestial bodies to peaceful purposes only and expressly prohibits their use for testing any kinds of weapons, conducting military maneuvers or establishing military bases, installations and fortifications. However, the Treaty does not prohibit the deployment of conventional weapons in orbit. The Treaty also puts that no state can claim ownership of an outer space body or part of it, and the sovereignty of states extends only to the space objects exclusively launched by them.

On <u>December 18, 1979</u> within the framework of the <u>UN</u> they concluded the agreement on the activities of states on the Moon and other celestial bodies.

It extends the <u>international law</u> to the <u>Moon</u> and all other <u>celestial bodies</u> except the <u>Earth</u>, including the orbits around these bodies.

Proclaims the principle of exclusively peaceful use of the Moon and other celestial bodies, the principle of equal rights of all <u>states</u> to the exploration of celestial bodies, the principle of inadmissibility of claims by any state to extend its <u>sovereignty</u> to any celestial body.

The agreement has come into force only for the few states that have <u>ratified</u> it, and among them there is not a single member of the <u>"big seven"</u>, a permanent member of the <u>UN Security Council</u> or a state with a substantial space program of its own. Thus, the agreement is not of a great political force at the moment.

The Convention on international liability for damage caused by space objects is an intergovernmental document signed by the <u>United Kingdom</u>, the <u>United States of America</u> and the <u>USSR</u> in <u>1972</u>, it expands the <u>1967 space Treaty</u>.

The purpose of signing the Convention is to establish effective international rules and procedures on liability for damage caused by space objects and to ensure, inter alia, prompt payment under its provisions to victims of such damage.

The importance of outer space for the life of mankind is constantly increasing. Today it is difficult to imagine the daily life of man without the Internet, Navigator, mobile phone; we can hardly imagine government and business structures without cybernetic control systems, systems of communication, navigation, weather reports, etc. Military affairs have already been mentioned above, we can only complement with the conclusion that today no unit and no headquarters of modern armies can do without space systems. However, the militarization of outer space, and especially military actions in space can not only lead to the death of the parties to an armed conflict, but to a crash of life support systems of many countries, causing numerous technogenic disasters, mass deaths of millions of people, with the survivors of humanity returning to the era of primitive entities. And the prediction of the Apocalypse coming true.

Stopping this insanity is a must and still possible. We need a strong international movement for the demilitarization of outer space, for the prohibition of the development of new types of

weapons of mass destruction, for the adoption of an effective international legal system, regulating the activities of countries and economic structures in outer space. Otherwise, Apocalypse inevitable.
